Stan was club president in 1982. His brother, Pete, was club president in 1984.


## Late September/Early October Fish Stories...



I trolled for kings from before sunrise to after sunset yesterday. Got 4 bites. Caught 2 little bluefish, 1 big false albacore, and pulled something off after a good run. It was just before I caught the albert so it was likely another one of those. All 4 bites came on the same plug, a "mullet" Rapala. Came home and caught little specks off of my dock. Caught the albert between the Santore and the CB Line. There was a lot of bait there. Ken Neill

#### Posted October 6, 2014 in FishTrack Online Newsletter:

Friday, Danny Forehand and I went over to the boat and got it ready for a planned wahoo trip on Sunday. We went out and trolled for king mackerel for a bit. We did not get a king. We did pull something off that may have been one and there were a few big kings caught by other boats. We were trolling four rods when two went off. During the fight, we managed to get all four lines crossed up and under the boat. We did land and release Danny's big jack crevalle. The fish I was fighting got in the wheel as we were landing Danny's. My diver had just cleared a bunch of line from the wheels. We put some more line back for his next dive.

It blew Saturday and Saturday night. I told the crew to check the weather and to decide if they still wanted to head offshore. The only hardy souls remaining Sunday were Phillip Neill, Chris Wyman, and Stan Simmerman. They said that they were good to go so down to the Cigar we went. The forecast was right on with big seas early but by mid-morning, it was an entirely different ocean. The wahoo liked the weather. We had about 15 wahoo bites and only managed to land 3. They were all nice fish with the smallest weighing in at 45 pounds, the largest at 85 pounds. We trolled a little spoon for a bit to see if there were any baby bluefin around for Dr. John Graves. There were baby blackfin. Phillip caught a big false albacore that managed to escape overboard from Stan's hands before we could measure it so no release citation for Phillip. The rest of us each weighed in a citation-size wahoo. These were the first-ever citation wahoo for both Stan and Chris. At 85 pounds, Stan started out big.

# Virginia Marine Resources Commission Acts on Fisheries Violations Votes Unanimously to Revoke Licenses

NEWPORT NEWS, VA. -- The Virginia Marine Resources Commission at their September 23, 2014, meeting took the following action on fisheries violations:

Brooks Dale Pruitt, of Onancock, Virginia. Mr. Pruitt, a licensed commercial fisherman has three convictions on three separate dates in one year: one count of possession of unculled crabs (November 13, 2013); one count of possession of unculled oysters (March 12, 2014); and one count of possession of hard crabs on a crab scrape boat (July 9, 2014). In accordance with Section 28.2-232 of the Virginia Code and guidelines set forth by the Law Enforcement Committee, the Virginia Marine Resources Commission voted unanimously to revoke all of Mr. Pruitt's fishing licenses for six months beginning on September 23, 2014 and ending on March 22, 2015. After revocation, Mr. Pruitt will be on probation for one year.

Charles A. Demarino, of Cape Charles, Virginia. Mr. Demarino, a licensed commercial fisherman was convicted of warm water violation for failure to provide shade over his shellfish on June 24, 2014. In accordance with Section 28.2-232 of the Virginia Code and guidelines set forth by the Law Enforcement Committee, the Virginia Marine Resources Commission voted unanimously to revoke all of Mr. Demarino's fishing licenses for a period of six months to begin on September 23, 2014 and end on March 22, 2015.

Christopher Nelson, of Water View, Virginia. Mr. Nelson, a licensed commercial fisherman has three convictions on May 19, 2014: one count of commercially landing striped bass without a permit; one count of failure to properly display a license tag; and one count of an improperly marked gill net. In accordance with Section 28.2-232 of the Virginia Code and guidelines set forth by the Law Enforcement Committee, the Virginia Marine Resources Commission voted unanimously to revoke all of Mr. Nelson's licenses for a period of one year, beginning on September 23, 2014 and ending on September 22, 2015. Following revocation, Mr. Nelson will be placed on one year probation.

Darwin R. Harding, of Lottsburg, Virginia. Mr. Harding, a licensed commercial fisherman, was convicted of a warm water violation for transporting oysters without approved temperature controlled storage on June 16, 2014. In accordance with Section 28.2-232 of the Virginia Code and guidelines set forth by the Law Enforcement Committee, the Virginia Marine Resources Commission unanimously to revoke all of Mr. Harding's licenses for a period of one year, September 23, 2014 to September 22, 2015.

Following the monthly meeting, Virginia Marine Resources Commissioner John M.R. Bull said "the Commission vote to unanimously revoke these individuals' fishing licenses continues a steady and consistent message from the Commission to the watermen, that violations of the Commonwealth's fisheries laws and regulations will not be tolerated. The Commission takes this responsibility seriously. We expect compliance."

#### 2014 PSWSFA Tournaments Rules

- Entry Fees: \$20 for member & \$30 for non-member. Youth and Ladies croaker/flounder tourney is free.
- "Awards" for Tournaments with a picnic, will be given out at the picnic. You must be present to receive your prize.
- You must register before fishing by e-mailing Rick Wineman: rick@getanetsportfishing.com or call 757-268-1539.
- Leaving a message will be sufficient to register, give all anglers names (specify club members and club guest), and also give a phone number.
- Guest(s) must fish with at least one member on boat/shore/pier/kayak
- Use a club "Official Entry Form" and weigh in fish at any Va. Saltwater Tournament official weigh station. Record
  the weight of fish, date and time caught and have the weigh master sign the form to verify catch. If two identical
  fish are caught on the same day, the earlier fish wins. That is why time is so important. Triple Threat entries
  require witness or photo since this is a length total tourney and trophy Reds are catch and release, and
  most Black Drum are also released.

#### MEASURING INSTRUCTIONS

With the fish lying on a flat surface, measure in quarter inch increments, from the tip of the mouth to the tip of the tail with the fish in a natural position and the mouth closed.
